#### 6. Community Policing Update RG

Continually working on Community Safety and the Neighbourhood Watch Groups, have partnered with the Mission to Seafarers to assist with seniors.

Seeking feedback on a "Safe Shop" program to roll out to retailers who would want to participate by having a sticker that lets kids know they can come into their store and seek refuge and call their parents or police if they are in danger. Noted there would be a process and flow chart for retailers to follow with simple steps for any employees to use.

Preference for the Chamber of Commerce to drive the initiative and Police to support it. ACTION: Meeting to be arranged with the Chamber, Police and the City. LY to contact the Chamber to let them know about the funding they can apply for to support this initiative.
