All assets will be managed and maintained in accordance to the best practice model of Aus-Spec, or equivalent alternate best practice system, in accordance with agreed service level agreements; 1.2. All assets and infrastructure will be budgeted in accordance with WAAMI principles, or equivalent alternate best practice system, through a 5-year budget process; 1.3. All existing reserves and restricted funds will be maintained into the future for their current specified purpose and within the originally prescribed geographic boundaries; and 1.4. It is understood that the Shire of Mullewa owned houses in their community.
